

## ORDINANCE NO. 08-56 AC CMS

### AN ORDINANCE AMENDING ORDINANCES 92-65 AC CMS, 97-102 AC CMS, 07-98 AC CMS, 07-51 AC CMS, and 07-82 AC CMS THAT AUTHORIZED ADDITIONAL COMPENSATION FOR THE PUBLIC WORKS DIRECTOR, DIRECTOR OF THE OBERLIN MUNICIPAL LIGHT AND POWER SYSTEM, THE FINANCE DIRECTOR, THE CLERK OF COUNCIL AND THE CITY MANAGER IN THE FORM OF A VEHICLE ALLOWANCE IN LIEU OF USE OF A MUNICIPAL VEHICLE

**BE IT ORDAINED** by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

**SECTION 1.** That the vehicle allowance provisions of Ordinances 92-65, 97-102, 07-98, 07-51 and 07-82 are hereby amended to provide for a vehicle allowance in accordance with the following sections.

**SECTION 2.** Effective the first calendar month following the effective date of this Ordinance, the City Manager, Finance Director, and the Clerk of Council are authorized to have an annual vehicle allowance in the amount of \$4,200, in lieu of a city provided vehicle. In addition, the City Manager is authorized to provide an annual vehicle allowance to department heads that do not have vehicles provided by the City for their use, subject to annual appropriation. Council Appointees and other employees receiving such an allowance are responsible for maintaining liability, property damage, and comprehensive insurance coverage and are responsible for gas, oil and all expenses associated with the purchase, operation, maintenance, and repair of their personal vehicle.

**SECTION 3.** The annual vehicle allowance as established in Section 2 shall be paid in equal payments on a monthly basis or such other schedule as determined by the Finance Director and City Manager.

**SECTION 4.** The vehicle allowance shall be adjusted proportionally in accordance with changes in the IRS standard mileage reimbursement rate, and rounded to the nearest whole dollar which is divisible by 2.

**SECTION 5.** In addition to the annual vehicle allowance, Council Appointees and other employees receiving such an allowance may be reimbursed for City business travel outside of Lorain County at the IRS standard mileage reimbursement rate.

**SECTION 6.** It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 7.** That this Ordinance shall take effect at the earliest date allowed by law.
