Cryptic naming of layers/files shall include a definition key. All electronic files shall be drawn in 1:1 scale. Minimum required information: 1) Floor plan - one plan for each building floor, all exterior/interior walls, all rated walls, all door locations including rollups and roof hatch/doors, stairs and elevator locations, room/suite name/numbers, utility shutoff locations, special hazards, high-piled stock/racks, all standpipe/sprinkler riser/fire extinguishing systems, alarm panels, FD connections, and key boxes; 2) Site plan - parking lot, building numbers, garages, fire lanes, hydrants; 3) Roof plan - layout and access.
