AN ORDINANCE ACCEPTING THE BID OF EDWARD'S TREE SERVICE, INC., OF AMHERST, OHIO, FOR FORESTRY SERVICES FOR THE CITY OF OBERLIN, OHIO, AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the bid of Edward's Tree Service, Inc., of Amherst, Ohio, for forestry services for the City of Oberlin, Ohio, for the 2008 tree work, being the lowest and best bid submitted, is hereby accepted, and the City Manager is hereby authorized and directed to enter into a contract accordingly, for the per item prices set forth in attached exhibit A, and in a total amount not to exceed \$70,000.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That the ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the City of Oberlin, Ohio, or in order to provide for the usual daily operation of a municipal department, to wit:

> "to accept a forestry bid as soon as possible in order to ensure emergency tree clearing and removal services", and shall take effect immediately upon passage.
