

## **ORDINANCE NO. 08-67AC CMS**

### **AN ORDINANCE AUTHORIZING AN INCREASE IN COMPENSATION FOR THE CITY CLERK/CLERK OF OBERLIN CITY COUNCIL AND AMENDING ORDINANCE 07-51 AC CMS APPOINTING THE CITY CLERK/CLERK OF OBERLIN CITY COUNCIL, FOR THE CITY OF OBERLIN, OHIO, AND DECLARING AN EMERGENCY**

**BE IT ORDAINED** by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

**SECTION 1.** That salary of the City Clerk/Clerk of Oberlin City Council is hereby increased to \$42,640 annually, effective May 28, 2008, plus those benefits provided in Ordinance No. 07-51 AC CMS.

**SECTION 2.** That subsections "2.", "3." and "4." of Section 1. of Ordinance 07-51 AC CMS, passed May 21, 2007 is hereby amended to read as follows:

2. All City of Oberlin full-time non-collective bargaining employee benefits, including, but not limited to, OPERS retirement contributions, medical insurance coverage, and vacation and sick leave.
3. A \$150 per month vehicle expense allowance, or an amount that may be subsequently established by City Council, to commence when the Clerk has enrolled in an accredited course of studies leading to the designation of Certified Municipal Clerk, travel outside of Lorain County shall be reimbursed at the appropriate IRS rate.
4. Reimbursement for tuition, fees, and other direct expenses related to the accredited course of study leading to the Certified Municipal Clerk designation, provided that the Clerk has enrolled in and remains in good standing in said course of study. This provision is in addition to other training, conference, educational benefits, etc., available to other non-collective bargaining employees.


**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

*"to provide for a merit increase for Clerk Anderson to coincide with her anniversary date," and shall take effect immediately upon passage.*
