ORDINANCE No. 19-67 AC CMS

AN ORDINANCE AMENDING THE CITY OF OBERLIN ZONING MAP TO REZONE PERMANENT PARCEL No. 14-000-16-000-032 STATE ROUTE 58 FROM "O"/OFFICE DISTRICT TO THE "C-3"/PLANNED HIGHWAY COMMERCIAL DISTRICT AND DECLARING AN EMERGENCY

WHEREAS, the City of Oberlin Planning Commission has reviewed Permanent Parcel No. 14-000-16-000-032 State Route #58 to determine whether the current zoning of this parcel is appropriate; and

WHEREAS, the Planning Commission has determined that rezoning this parcel would make its zoning consistent with the existing "C-3" zoning in the immediate vicinity and would rezone it to a district which was the most appropriate for a busy highway location; and

WHEREAS, the Planning Commission voted on September 4, 2019 to recommend to the City Council that this property be rezoned to "C-3"/Planned Highway Commercial District; and,

WHEREAS, this Council held a public hearing on October 21, 2019 concerning the Planning Commission's recommendation; and,

WHEREAS, this Council has voted to adopt the recommendation of the Planning Commission.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the parcel of real property identified in Exhibit "A" attached hereto is hereby rezoned to "C-3"/Planned Highway Commercial District.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit: to facilitate economic development in the City of Oberlin and to amend the title and substance accordingly and shall take effect immediately upon passage.


