COMMERCIAL <u>RECYCLING</u> COLLECTION SERVICES

Corrugated Cardboard Recycling: *Corrugated Cardboard Only* dumpsters are available for customers who generate a significant amount of corrugated cardboard.

Corrugated Cardboard Only Recycling Guidelines

Corrugated cardboard is easily identifiable by the ribbed section sandwiched between two flat layers of paper. Remove all packing material and flatten box(es) before placing in your cardboard only recycling dumpster. Incidental tape, staples, etc. do not need to be removed. Do not recycle other paper products such as newspapers, boxboard, waxed or glossy cardboard, magazines, or office paper with corrugated cardboard.

Mixed, Single Stream Recycling: Using a combination of 96-gallon carts and/or 2-yard, 4-yard and 6-yard rear load dumpsters, the City may provide single-stream recycling collection to select customers. The type, size and quantity of containers as well as the service schedule will be based on the needs of each customer and our ability to provide service.

Single-Stream Recycling Guidelines

Recyclables must be placed in your container loose; bags are considered contaminant and are not accepted in your recycling cart/dumpster. Empty and rinse all containers and flatten all boxes.

- **Plastic:** #1 #2 only. Beverage, detergent bottles/jugs.
- Aluminum, Steel & Bi-metal cans: food & beverage cans and lids, opened with a can opener or pull-top ring.
- **Mixed Paper:** including newspaper & inserts, magazines, junk mail, phone books, box board, paper bags and paper towel tubes.
- **Cardboard:** emptied and broken down.
